THE EXHIBITOR AND AWDC AGREE AS FOLLOWS:

1. PAYMENT DUE BY EXHIBITOR FOR THE FLOOR SPACE OF THE TRADE FAIR

AWDC is due a total sum of for the floor space of The Exhibitor. AWDC handles all payments with the Trade Fair organizer.

AWDC will invoice the above amount immediately to the Exhibitor after signature of this agreement.

2. OTHER PROVISIONS



AWDC can NOT guarantee a booth nor the requested size or desired location of the booth and the Exhibitor can not hold AWDC liable for not providing a booth, or for not providing a booth with the desired size and location or annul the Floor Space Agreement for not providing the Exhibitor with the desired location and/or size of the booth. Nevertheless, advance payment according to this agreement is mandatory. A partial refund will be provided by AWDC depending on the floor space price of the final booth (according to size) assigned to the Exhibitor or a full refund will be provided by AWDC if no booth is available. The Exhibitor cannot request a full refund (or cancellation of the Floor space Agreement) in the event that AWDC has available a booth of at minimum 9 sqm for the Exhibitor.

If a booth is available for the Exhibitor and the Exhibitor is assigned a booth based on participation in a lottery (see Terms & Conditions for lottery procedures), the Exhibitor will be required to sign a separate Exhibitor Agreement detailing location, construction, promotional services and exact size of his Booth. Construction and promotional services (at cost price) as well as a service fee for AWDC will be charged to the Exhibitor as agreed and detailed in a separate Exhibitor Agreement

Cancellation of your booth and/or this agreement after signing the underlying Floor Space Agreement involves payment of 100% of the floor space charges according to art. 1.

The Exhibitor hereby agrees to the Terms and Conditions version... of the Antwerp Diamond Pavilion, which are handed over together with this agreement. The most recent version of the Terms and Conditions (which is applicable at all times) can be found on the AWDC website,, www.awdc.be.
