In addition to this Floor Space Agreement, the Exhibitor is required to sign a separate Exhibitor Agreement, which will detail the booth's location, construction, promotional services, and exact size. Costs associated with construction, promotional services (at cost price), and a service fee for AWDC will be charged as specified in the Exhibitor Agreement.

The Exhibitor acknowledges that by signing this Floor Space Agreement, AWDC does not guarantee the assignment of any specific booth location assignment. AWDC will not be held liable, nor can this agreement be annulled, should the desired location be unavailable.

As outlined in the Terms and Conditions, the signature of this Floor Space Agreement does not guarantee participation. AWDC reserves the right to revoke participation in the trade fair if fees for the current fair remain unpaid by the invoice due date or if outstanding payments from previous fairs have not been settled.

While AWDC endeavors to allocate the requested booth size, provided it is the same as or smaller than the previous year, it does not guarantee the availability of larger booths. Upfront payment, as stipulated in this Agreement, remains mandatory.

If a larger booth is requested but unavailable, the Exhibitor will generally be assigned a booth of the same size as the previous year. In such cases, AWDC will refund the price difference between the floor space assigned and the floor space paid for, according to this Agreement.

Booth cancellations after signing this Floor Space Agreement will incur a charge equal to 100% of the floor space fees, as outlined in Article 1 of this agreement.

By signing, the Exhibitor agrees to the Terms and Conditions, version 07.12.2023, of the Antwerp Diamond Pavilion. The latest version of the Terms and Conditions, which is always applicable, can be found on the AWDC website at www.awdc.be.
